Engineered Timber Flooring as specified in our range statement.

Description of Engineered Timber Flooring

Bjelin Engineered Timber Flooring refers to a multi-layered modular wood floor covering, typically composed of a hardwood 2.5 mm or greater veneer top layer bonded to a wood block or plywood core and a wood veneer backing board makes up the stabilising base layer.

Belgotex (NZ) Ltd supplied Bjelin Engineered Timber Flooring can be floated or direct stuck and utilises a joint click lock system for assembly.

When installed, Bjelin Engineered Timber Flooring may contribute to G6 (airborne & impact sound) or H1 (energy efficiency) of the building.

Engineered wood flooring is supplied in plank format and sold by the square metre.

For all building classified uses.	 Bjelin Engineered Timber Flooring is for interior use only. The substrate must have a relative humidity of 75% or below. Must be laid in accordance with Bjelin installation guidelines. When installed in wet areas the flooring be installed as detailed in Belgotex NZs wet area installation guidelines. Not recommended for bathrooms or saunas.
For use as a flooring in an access route.	Bjelin Engineered Timber Flooring has slip testing declarations in accordance with CEN/TS 15676:2008 with equivalents found in AS 4586:2013.
In connection with underfloor heating including in-slab piped water heating.	Bjelin Engineered Timber Flooring is suitable for use with underfloor heating not exceeding 27°c.
